FOR FILLIES AND MARES, THREE YEARS OLD AND UPWARD By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$3,000 at time of entry (includes entry and starting fees). \$500 to enter and an additional \$500 to start, with \$100,000 guaranteed, of which \$60,000 to the owner of the winner, \$20,000 to second, \$10,000 to third, \$5,000 to fourth, \$3,000 to fifth and \$2,000 to be divided equally among sixth through last. Weight: Three year olds, 120 lbs.; Older, 125 lbs Non-winners of \$58,000 on the turf since October 6, allowed 3 lbs.; a graded stakes on the turf since July 4, 5 lbs. The maximum number of starters for the Giant's Causeway will be limited to fourteen with two also eligibles. In the event that more than fourteen fillies or mares pass the entry box, the fourteen starters will be determined at that time with preference given to graded stakes winners (in order I-II-III), then highest 2017-2018 turf earnings. Starters to be named through the entry box by the usual time of closing. A set of two silver julep cups will be presented to the winning owner.
