FOR THREE YEAR OLDS AND UPWARD By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$6,000 at time of entry (Includes entry and starting fees). \$1,000 to enter and an additional \$1,000 to start, with \$200,000 guaranteed, of which \$120,000 to the owner of the winner, \$40,000 to second, \$20,000 to third, \$10,000 to fourth, \$6,000 to fifth and \$4,000 to be divided equally among sixth through last. Weight: Three year olds, 120 lbs.; Older, 125 lbs. Non-winners of a Grade I stakes on the turf since November 3, allowed 3 lbs.; a Grade II or Grade III stakes on the turf since October 6, 5 lbs. The maximum number of starters for the Shakertown will be limited to fourteen with two also eligibles. In the event that more than fourteen pass the entry box, the fourteen starters will be determined at that time with preference given to graded stakes winners (in order I-II-III), then highest turf earnings in 2017-2018. Starters to be named through the entry box by the usual time of closing. Keeneland will present a trophy cup to the winning owner.
