FOR THREE YEAR OLDS By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$4,500 at time of entry (includes entry and starting fees), \$750 to enter and an additional \$750 to start, with \$150,000 guaranteed, of which \$90,000 to the owner of the winner, \$30,000 to second, \$15,000 to third, \$7,500 to fourth, \$4,500 to fifth and \$3,000 to be divided equally among sixth through last. Weight: 123 lbs. Non-winners of a graded stakes at a mile or over on the turf allowed 3 lbs.; \$45,000 at a mile or over on the turf, 5 lbs. The maximum number of starters for the Transylvania will be limited to fourteen with two also eligibles. In the event that more than fourteen pass the entry box, the fourteen starters will be determined at that time with preference to graded stakes winners (in order I-II-III), then highest turf earnings. Starters to be named through the entry box by the usual time of closing. Keeneland will present a trophy cup to the winning owner.
