The nominated winner will also be entitled to have pre-entry and entry fees waived for the 2024 Breeders' Cup Mile or will receive a credit equal to the Breeders' Cup Mile pre-entry and entry fee amount towards any other 2024 Breeders' Cup Championship race. All horses will be entitled to receive a travel stipend if traveling from a base located outside the state of California. To be eligible for the 2024 Breeders' Cup World Championship races are to be run Lasix free and in accordance with Breeders' Cup Limited rules as they may be published and/or amended from time to time, which rules are hereby incorporated by this reference. All runners nominated to Challenge races and all Challenge winners are subject to out-of-competition testing by HIWU on behalf of HISA (or their respective designees).
