# 2024 November Horses of Racing Age Sale

# **Thursday, November 14**

## Entry Fee & Commission Structure

The entry fee for all Keeneland sales is \$1,000. The sales commission will be 5% on bids exceeding \$10,000 with a minimum commission of \$500 per sale. The RNA commission will be 2.5% on bids exceeding \$10,000. See below for examples of this structure at different price points:

	All horses must be vaccinated against Equine Herpes Virus Type 1 (EHV-1) by a licensed veterinarian a minimum of fourteen (14) days and no more than one hundred and twenty (120) days prior to sale date. Proof of vaccination date and product used must be emailed to mjohnson@keeneland.com or included on the Health Certificate
	Jockey Club Registration certificates due  Digital registration transferred to Keeneland Association, Inc.  Original registration certificates turned into Sales Office
	Consignor's Authorized Agent form emailed to  pmaley@keeneland.com  • Keeneland must have an owner's signature on file for every consigned horse in the sale  • One partner's signature is sufficient for all partners  • Form must be filled out completely and notorized (DocuSign or other Kentucky authorized electronic notary accepted)  • If owned in part or in total by consignor, no AA form needed

	<ul> <li>X-rays to Repository: Must be taken within 10 days of sale date.</li> <li>X-rays, endoscopic videotapes and veterinary certificates must be on file in the Repository at least four days prior to sale date.</li> <li>Veterinarians need to reach out to awhalen@keeneland.com for directions on uploading x-rays into the repository.</li> </ul>
	All broodmare prospects must have a veterinary certificate on file

stating "suitable for mating" and be dated within 10 days of selling
