FOR THREE YEAR OLDS By subscription of \$100 each which should accompany the nomination or by Supplementary Nomination of \$4,000 by time of entry (Includes entry and starting fees). \$1,000 to enter and an additional \$1,000 to start, with \$250,000 guaranteed plus an additional \$50,000 KTDF for KTDF eligible horses. After payment of 1.25% to each owner of horses finishing sixth through last, 62% of the remaining association purse will be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth. KTDF funds correspondingly divided providing a KTDF eligible horse finishes in an award position. Weight: 123 lbs. Non-winners of a Grade I or II in 2024, allowed 3 lbs.; a sweepstakes since April 5, 5 lbs. The maximum number of starters for The Perryville will be limited to twelve. In the event that the race overfills the starters will be determined at that time with preference given to graded or group stakes winners (in order I-II-III), graded stakes placed (in order I-II-III), non-restricted stakes winners then condition preference. Starters to be named through the entry box by the usual time of closing. A Keeneland trophy cup will be presented to the owner of the winner.
