

30th Running Of The Sycamore \$300,000

(Includes \$50,000 from KTDF)

FOR THREE YEAR OLDS AND UPWARD By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$5,000 by time of entry (Includes entry and starting fees). \$1,250 to enter and an additional \$1,250 to start with \$250,000 guaranteed plus an additional \$50,000 KTDF for KTDF eligible horses. After payment of 1.25% to each owner of horses finishing sixth through last, 62% of the remaining association purse will be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth. KTDF funds correspondingly divided providing a KTDF eligible horse finishes in an award position. Weight: Three year olds, 122 lbs.; Older, 126 lbs. Non-winners of a Grade I over ten furlongs on the turf in 2023-2024 allowed 2 lbs.; a graded stakes over nine furlongs in 2024, 4 lbs. The maximum number of starters for the Sycamore will be limited to twelve, with four also eligibles. In the event that the race overfills the starters will be determined at that time with preference given to graded or group stakes winners over nine furlongs (in order I-II-III), graded or group stakes placed (in order I-II-III), non-restricted stakes winners over nine furlongs, then condition preference. Starters to be named through the entry box by the usual time of closing. (If this race is taken off the turf it will be downgraded one grade level for this running only in accordance with American Graded Stakes Committee policy). A Keeneland trophy cup will be presented to the owner of the winner.
