

## 44th Running Of The Thoroughbred Club of America "Win and You're In Breeders' Cup Filly & Mare Sprint Division" \$350,000

FOR FILLIES AND MARES, THREE YEARS OLD AND UPWARD By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$6,000 by time of entry (Includes entry and starting fees). \$1,500 to enter and an additional \$1,500 to start, with \$300,000 guaranteed plus an additional \$50,000 KTDF for KTDF eligible horses. After payment of 1,25% to each owner of horses finishing sixth through last, 62% of the remaining association purse will be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth. KTDF funds correspondingly divided providing a KTDF eligible horse finishes in an award position. Weight: Three year old fillies, 122 lbs., Older, 124 lbs. Non-winners of a Grade I in 2024, allowed 2 lbs.; a Grade II or Grade III in 2024, 4 lbs. The Thoroughbred Club of America has been selected as one of the Breeders' Cup Filly and You're In" Challenge Races. The nominated winner of the Thoroughbred Club of America will be entitled to automatic entry into the 2024 running of the Breeders' Cup Filly & Mare Sprint Division or will receive a credit equal to the Breeders' Cup Filly & Mare Sprint Division pre-entry and entry fee amount towards any other 2024 Breeders' Cup World Championship race. All horses will be entitled to receive a travel stipend if traveling from a base located outside the state of California. To be eligible for the 2024 Breeders' Cup World Championships held at Del Mar on November 1 and 2, 2024, all horses must be pre-entered by noon (local standard time at the designated place of pre-entry) on Monday, October 21, 2024. Winner must be nominated by pre-entry deadline to receive Challenge rewards. All Breeders' Cup Challenge Races and Breeders' Cup World Championship races are to be run Lasix free and in accordance with Breeders' Cup Limited rules as they may be published and/or amended from time to time, which rules are hereby expressly incorporated by this reference.
