(Grade II)**

(Includes \$50,000 from KTDF)

FOR FILLIES, THREE YEARS OLD By subscription of \$100 each which should accompany the nomination or by Supplementary Nomination of \$5,000 by time of entry (Includes entry and starting fees). \$1,250 to enter and an additional \$1,250 to start, with \$300,000 guaranteed plus an additional \$50,000 KTDF for KTDF eligible horses. After payment of 1.25% to each owner of horses finishing sixth through last, 62% of the remaining association purse will be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth. KTDF funds correspondingly divided providing a KTDF eligible horse finishes in an award position. Weight: 122 lbs. Non-winners of a Grade I at a mile or over on the turf in 2024, allowed 2 lbs.; a Grade II at a mile or over on the turf in 2024, 4 lbs. The maximum number of starters for the Bank of America Valley View will be limited to twelve, with four also eligibles. If this race is transferred to the main track the field will be limited to fourteen. In the event that the race overfills the starters will be determined at that time with preference given to graded or group stakes winners (in order I-II-III), graded stakes placed (in order I-II-III), non-restricted stakes winners then condition preference. Starters to be named through the entry box by the usual time of closing. (If this race is taken off the turf it will be downgraded one grade level for this running only in accordance with American Graded Stakes Committee policy). A Keeneland trophy cup will be presented to the owner of the winner.
