

24th Running Of The Buffalo Trace Franklin County \$150,000 (Grade III)

FOR FILLIES AND MARES, THREE YEARS OLD AND UPWARD By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$4,500 by time of entry (Includes entry and starting fees). \$750 to enter and an additional \$750 to start, with \$150,000 guaranteed, of which \$90,000 to the owner of the winner, \$30,000 to second, \$15,000 to third, \$7,500 to fourth, \$4,500 to fifth and \$3,000 to be divided equally among sixth through last. Weight: Three year olds, 122 lbs.; Older 124 lbs.; Non-winners of a graded sweepstakes on the turf in 2020, allowed 2 lbs.; a graded sweepstakes in 2020 or \$50,000 twice on the turf in 2020, 4 lbs. The maximum number of starters for the Buffalo Trace Franklin County will be limited to fourteen with two also eligibles. If this race is transferred to the main track the field will be limited to fourteen. In the event that the race overfills the starters will be determined with preference given to graded stakes winners (in order 1-11-11), then highest non-restricted turf earnings in 2020. Starters to be named through the entry box by the usual time of closing. A Keeneland trophy cup will be presented to the owner of the winner.
