## 30th Running Of The JPMorgan Chase Jessamine "Win And You're In Breeders' Cup Juvenile Fillies Turf Division" \$150,000 (Grade II)

**FOR FILLIES, TWO YEARS OLD** By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$4,500 by time of entry (Includes entry and starting fees), \$750 to enter and an additional \$750 to start, with \$150,000 guaranteed, of which \$90,000 to the owner of the winner, \$30,000 to second, \$15,000 to third, \$7,500 to fourth, \$4,500 to fifth and \$3,000 to be divided equally among sixth through last. Weight: 122 lbs. Non-winners of a group or graded stakes on the turf allowed 2 lbs.; a sweepstakes at a mile or over, 4 lbs. The JPMorgan Chase Jessamine has been selected as one of the Breeders' Cup "Win and You're In" Challenge Races. The nominated winner of the JPMorgan Chase Jessamine will be entitled to automatic entry into the 2020 running of the Breeders' Cup Juvenile Fillies Turf Division, nominated winner will be entitled to have pre-entry and entry fees waived for the Juvenile Fillies Turf or will receive a credit equal to the Juvenile Fillies Turf pre-entry and entry fee amount towards any other Breeders' Cup Championship race, and all horses will be entitled to receive a travel stipend if traveling from a base located outside the state of Kentucky. To be eligible for the 2020 Breeders' Cup World Championships held at Keeneland on November 6 and 7, 2019, all horses must be pre-entered by noon (local standard time at the designated place of pre-entry) on Monday, October 26, 2020. Winner must be nominated by pre-entry deadline to receive Challenge rewards. In the event this race is taken off the turf, due to unsafe racing conditions, the horse that wins the "off the turf" race will NOT receive an automatic qualifying position and will NOT receive the starting fees (the total of pre-entry and entry fees) to enter the Breeders' Cup World Championships in the applicable Turf Division race; provided, however, that Breeders' Cup Limited may, at its option, reinstate the "Win and You're In" status of the "off the turf" race. The decision to take a Breeders' Cup Challenge Division turf race off the turf course is under the sole discretion of the racetrack/racing association, not Breeders' Cup Limited. All Challenge winners are subject to out-of-competition testing by the Kentucky Horse Racing Commission and/or BCL. All runners are subject to out-of-competition testing by the Kentucky Horse Racing Commission and/or BCL. Breeders' Cup Limited reserves the right in its sole discretion to postpone, discontinue, amend or change the conditions of all or any part of the Breeders' Cup Challenge "Win and You're In" race program. The maximum number of starters for the JPMorgan Chase Jessamine will be limited to fourteen, with two also eligibles. If this race is transferred to the main track the field will be limited to fourteen. In the event that the race overfills the starters will be determined at that time by fillies that have finished first, second or third in a graded stakes, non-restricted stakes winners then condition preference. For Two Year Olds under International Medication Protocol. Horses nominated or entered to compete shall not be eligible to receive furosemide less than twenty-four (24) hours prior to post time for the race. Starters to be named through the entry box by the usual time of closing. A Keeneland trophy cup will be presented to the owner of the winner.
